The cost of Plan A, B or C will be billed monthly through FACTS Tuition Management. As with tuition, parents will choose the day of the month for the amount to be deducted, or they can choose to prepay the entire year prior to the start of the school billing cycle. ***For each plan, the cost of attendance has been calculated for the entire school year, and, in order to help our families to plan monthly expenses, this annual amount has been divided into 10 equal payments which are listed above.*** The first payment will be deducted in August.

Families on a **drop-in basis** will be billed and parents will be able to pay by check, cash, credit card or billed through their FACTS account. PLEASE MAKE ALL CHECKS PAYABLE TO ST. MARY'S SCHOOL. All enrollment plans include one daily snack and any activity supplies.
